Dear Current and Prospective Tribute Supporter:

On 2 March 2012, the Tribute to Women in the Military will mark its 27th anniversary at the Kirtland Air Force Base Mountain View Club, Albuquerque. This non-profit multi-service activity honors all military women (active and veterans) as well as civilian women affiliated with the Department of Defense. The program presents a keynote speaker, workshops, exhibits, luncheon, awards, and other acknowledgements. This is the longest-running event of its kind for military and DoD women at a military installation. The theme for 2012 is “Giving Back”.

We are seeking donations from businesses for doorprizes and small items for the tote bags that attendees receive. We give attendees (250, including men) a tote bag with donated items. Donors receive recognition in the program, and publicity before, during, and after the event. In addition, we seek corporate sponsorship in the form of cash donations. Supporters may also have an exhibit booth by e-mailing Kelly Aldrich ([exhibits@tributetowomeninthemilitary.org](mailto:exhibits@tributetowomeninthemilitary.org)), Exhibits Chair. There is no charge to exhibit, and is on a first-come basis for the limited space. You do not have to have 250 of an item—we will be grateful for whatever you can provide for the tote bags.

While this event is held on base and in conjunction with Women’s History Month, the Tribute is a private organization, registered on base, and covers its expenses through donations and the registration fee. Cash donations help cover travel for the keynote speaker, mailings, registration materials, table decorations, program, and administrative costs. Again this year, through your generous donations, we have reduced the fee for junior enlisted members to below our actual costs, and our World War II veterans are free. Attendees include students as well. Contributions are tax deductible to the extent allowed by law [section 501(c)(19) IRS Code - veterans organizations], and donations of \$250 or more will be acknowledged in writing.
